

## Understudy Sitters, LLC Vaccination & Disease Risk Policy

1. Client agrees that all pets are current on all Core (legally required) vaccinations before and throughout the whole service dates.

2. Any veterinary appointments that are scheduled within dates of service can be completed by Understudy Sitters, LLC staff at the expense of the owner, including an additional transport fee to be paid to Understudy Sitters, LLC.

Clients who willfully or intentionally misrepresent or withhold information regarding a pet's vaccination status or lack thereof agree to assume full liability for any and all related costs for loss, damage, or harm to Understudy Sitters, LLC and other affected parties. Liability examples include but are not limited to reimbursement of all or partial expenses to cover any result or investigation of disease transfer between the same or different species of host, injuries, death, property damage and/or loss, and related travel expenses.
  - a. This liability DOES NOT APPLY TO and IS NOT ASSUMED by clients who make any pet's vaccination exemptions known to the service provider IN ADVANCE of said requested or scheduled services.
4. Services provided to animals with medical exemptions to any vaccinations listed above are reviewed on a case-by-case basis.
5. Client hereby understands that vaccinations are a preventative, and while Non-core (elective) vaccinations are **HIGHLY ENCOURAGED** for any pets that are deemed fit to receive them, even fully vaccinated pets are able to contract disease from first or third party transfer. As such, the client acknowledges this inherent risk of disease transfer and hereby releases Understudy Sitters, LLC from any liability regarding accidental or circumstantial damages caused in these manners.
6. Understudy Sitters, LLC agrees to clearly and honestly update and communicate with clients regarding any outbreak or increase in instances of certain diseases, illness, or symptoms they are made aware of and allow clients to determine if they would like to keep, cancel, or reschedule services based on their personal risk assessment.
